- *2. **HEARING CONCERNS OF HSBA SECTIONS** Nine bar members representing five Sections (Walter Davison, Jerrold Guben, James Hochberg of Bankruptcy Law; Steven Guttman, David Farmer, William Plum of Collection Law; Gregory Kugle of Real Property & Financial Services; Dyan Medeiros of Family Law; and Trina Yamada of Child Law) expressed concerns over the relationship between HSBA and its Sections. Different concerns were voiced by the various Sections ranging from the Sections' autonomy and control over their finances to not receiving their membership lists in a timely manner. President Hugh Jones thanked the section representatives for their input and comments. He further explained that the reporting procedures were still being worked on and that Sections would be informed when the procedures are finalized. These Section representatives left the meeting after this discussion.
 - 3. **APPROVAL OF MINUTES** Minutes of the February 25th board meeting were approved by consensus.
 - 4. **TREASURER'S REPORT** Treasurer Craig Wagnild referred to the income statement ending 03/31/2010. He noted that membership dues revenue was slightly higher than projected for March and penalties were lower than projected. He also reported that non-dues income was down, so total income was lower than projected. However, total expenses were also lower than projected, so HSBA is ahead of budget to date.
 - 5. **EXECUTIVE DIRECTOR'S REPORT** Executive Director Lyn Flanigan reported that: a) staff was retrained in CPR earlier this month; b) webcast training is being offered to Sections; c) proposal is being offered to Sections to develop their own website through Esqsites123.com; d) demographic report on ethnicity run for the first time. Governor Aiona and one will also be signed by Mayor Hanneman.
